ORDINANCE CREATING THE COLLEGE OF MEDICINE AND ADVANCED HEALTH SCIENCES OF OSPITAL NG MUNTINLUPA MEDICAL CENTER AS LOCAL ECONOMIC ENTERPRISE (LEE)

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them as provided by Section 15 Article II Declaration of Principles and State Policies of Philippine Constitution and it is further provided in Section 1 Article XIV "to protect and promote the right of all citizens to quality education at all levels and to take appropriate steps to make education accessible to all.

WHEREAS, Republic Act 11223 otherwise known as "*Universal Health Care law*" mandates local government units (LGUs) to exercise administrative and technical supervision over health facilities and health human resources within their respective territorial jurisdiction as provided by Chapter V Organization of Local Health Systems Sec 19 Integration of local health system into Provincial-wide and Citywide-health system." Likewise, the Department of Health (DOH), together with stakeholders, shall ensure the formulation and implementation of a National Health Human Resource Master Plan that will provide policies and strategies for the appropriate generation, recruitment, re training, regulation, retention and reassessment of health workforce on population health needs as stated in its Section 23 National Health Human Resource Master Plan Chapter VI Human Resources for Health.

WHEREAS, the recently enacted Republic Act 11509 otherwise known as "*Doktor Para sa Bayan Act*" provides great opportunity to students to have access to quality medical education with the end in view of protecting or promoting the right to health of the people enshrined in our fundamental law;

WHEREAS, Ospital ng Muntinlupa Medical Center has approved through its Management Committee the establishment of College of Medicine and Advanced Health Sciences as Local Economic Enterprise and functions as corporate body, that it can undertake business enterprises as a mode of production and delivery of goods and services to its constituents.

WHEREAS, Creation of Ospital ng Muntinlupa College of Medicine and Advanced Health Sciences will sustain the hospital's growth and development allowing it to be the prime mover in the implementation of Universal Health Care not only in providing affordable tertiary level quality healthcare but a sustainable supply of health worker force to all residents of Muntinlupa and nearby communities who still lack a tertiary public hospital.

NOW THEREFORE, ORDAIN, AS IT HEREBY ORDAINED, by the 9th Sangguniang Panlungsod of Muntinlupa, in Session Assembled that:

SECTION 1. NAME - The name of the academic arm shall be, "**Ospital Ng Muntinlupa Medical Center College of Medicine and Advanced Health Sciences**" or "OMMC-CMAHS" for brevity;

SECTION 2. Structure and Operation

- Ospital ng Muntinlupa Medical Center (OMMC) shall remain its existing operation under the new VISION of "**To be the best local government hospital providing quality universal healthcare coverage and a sustainable health delivery system thru an efficient and compassionate healthcare workforce with premium education and training**"
- The addition of its academic arm **OMMC-CMAHS** will fall under the **Professional Education and Training** which is directly under the **Medical Center Chief**:

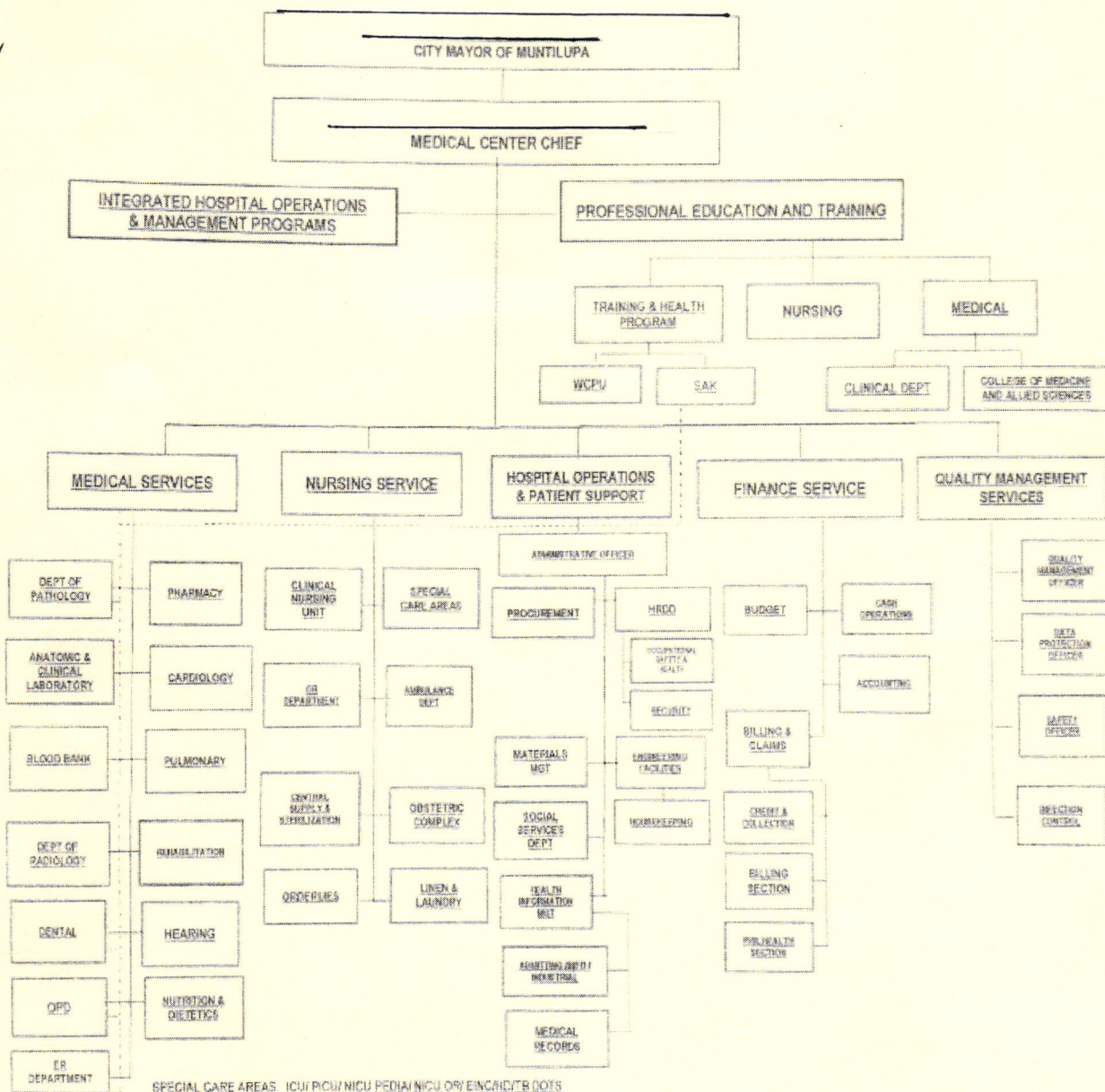

- c. The new OMMC with its academic arm CMAHS will operate as configured with the Universal Health Care Law at the outset with the goal of molding students abreast with the existing government healthcare system that will eventually become public health servants and managers with commitment in government service.
- d. The College of Medicine and other colleges that will be created in the future will be under their respective appointed Dean and will operate in compliance with Center for Higher Education requirements.

Each shall continue under the control of its own officers and shall remain solely responsible in all respects for the management of its own affairs subject to the supervision of the City Government of Muntinlupa, the OMMC, the Commission on Higher Education (CHED) and, the pertinent laws, rules and regulations;

- e. The appointed Department Heads in compliance with CHED requirements shall be the automatic Department Heads of Clinical Department of OMMC without additional compensation as part of their public service.
- f. The appointed faculty will likewise be part of the consultant staff of clinical department of OMMC without additional compensation as part of their public service.
- g. All other administrative operation like Human Resource, Business Office, Maintenance and Utilities will fall under the general operation of OMMC.

SECTION 3. Appointment of Officers and Faculty

- a. The OMMC-CMAHS shall retain the exclusive right to appoint its officers and faculty, subject to the requirements of CHED and in consultation with the Clinical Department and Human Resources of OMMC.
- b. Officers and Faculty are employed and remunerated by OMMC with the equivalent salary grade of a Medical Specialist in a Level 3 hospital subject to existing rules of Civil Service Commission.
- c. Appointed Officers and Faculty will be subjected to policies as set in the Faculty Manual.

SECTION 4. Acceptance to The Program

- a. The requirements and procedures for admission to Philippine medical schools to both Filipino and foreign nationals aspiring to pursue medical education in any of the recognized medical schools based on the "Updated Policies, Standards and Guidelines for Medical Education", CHED Memorandum Order (CMO) No. 10, series of 2006. are applicable to acceptance to the program of OMMC-CMAHS.
- b. Scholarship grants maybe given through the National, Local and Non-Government Organization programs subject to their respective guidelines.
- c. All other policies will apply as provided by Student Manual.

SECTION 5. Budget

- Budget will be coming from yearly approved budget of Ospital ng Muntinlupa Medical Center (OMMC).
- Personnel Service** – Plantilla positions of officers, faculty and other staff of CMAHS will be coming from approved allocated positions of OMMC.
- Maintenance and Other Operating Expenses (MOOE)** - Maintenance and utility expense will be part of MOOE of OMMC
- Capital Outlay (CO)** – Building structure, machinery, books and equipment will be coming from CO of OMMC as approved by the City Government of Muntinlupa.

SECTION 6. Income - Generated income of College of Medicine and Advanced Health Sciences (CMAHS) will form part of the gross income of OMMC as Local Economic Enterprise (LEE).

SECTION 7. Transitory Provision.

- Pending the availability of building structure for OMMC-CMAHS, OMMC will have a Memorandum of Agreement (MOA) with the Pamantasan ng Lungsod ng Muntinlupa for its initial application and operation under the name of PLMun-Osmun College of Medicine.
- The term of the MOA shall commence from the date of approval, and shall continue thereafter unless amended or revoked, or until such time that OsmunMC has its own facility for the College of Medicine and Advanced Health Sciences.

SECTION 8. Effectivity - The operation of OMMC-CMAHS will commence once approved and will continue to operate in compliance with CHED r
