WHEREAS, Section 455 (b)(1) (xvi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, 'the city mayor shall represent the city in all its business transaction, to sign in its behalf all bonds' contracts' and obligations, and such other document upon authority of the Sangguniang Panlungsod pursuant to law or ordinance";

WHEREAS, Section 5 of Republic Act 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 provides for the Reengineering of Systems and Procedures where all offices and agencies which provide government services are hereby mandated to regularly undertake cost compliance analysis, time and motion studies, undergo evaluation and improvement of their transaction systems and procedures and reengineer the same if deemed necessary to reduce bureaucratic red tape and processing time;

WHEREAS, the pandemic of 2020 has limited the physical movement of people thereby government services have to evolved in order to extend its services to most of its constituents especially to those who have been supporting the operation of the local authorities through payment of taxes, fees and licenses;

WHEREAS, the procurement of courier and delivery services is an innovative mechanism not merely for the convenience of the taxpayers but in compliance with health protocols and imposed quarantine levels;
