**WHEREAS**, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall: (i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

**WHEREAS**, Article 101, (a)(14) of Rules and Regulations Implementing the Local Government Code of 1991, provides that, "the Sangguniang Barangay as the legislative body of the Barangay shall provide fines in amount not exceeding One Thousand Pesos (Php1,000.00 for violation of Barangay Ordinance.";

**WHEREAS**, on June 10, 2021, the Barangay Ayala Alabang enacted Ordinance No. 06-01 Series of 2021, otherwise known as the Anti-Littering Ordinance;

**WHEREAS**, on June 18, 2021, the enacted ordinance was endorsed to the Sangguniang Panlungsod Secretary and was calendared on First Reading on June 21, 2021 for review of the Sangguniang Panlungsod;

**WHEREAS**, upon review of the Barangay Ordinance No. 06-01 Series of 2021, the penalties to be imposed is within the compliance of Republic Act No. 7160 or the Local Government Code of 1991;
