WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

WHEREAS, the **Health Facilities Enhancement Program (HFEP)**, implemented by the Department of Health with the main goal of improving the delivery of basic, essential and as well as specialized health services, was originally conceived as a plan to utilize the budget which consisted mostly of capital outlay for the **Philippine Hospital Development Plan (PHDP)** of 2000 but through the years evolved and included other types of health facilities services and later was extended to health facilities of local government units;

WHEREAS, the City Government of Muntinlupa is one of the recipients of the HFEP and was granted **four (4)** units of Ambulance with equipment which vehicle shall be distributed to barangays **Sucat (2 units), Putatan (1 unit) and Bayanan (1 unit)**;

WHEREAS, the grant of ambulance unit with equipment to the named barangays should conform to the provisions and terms of the grant as well as with **Department Order No. 2018-0001**;

WHEREAS, the Legal office finds the conditions reasonable and poses no objection to the said donation;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to grant authority to the City Mayor Atty. Jaime R. Fresnedi to represent the City Government of Muntinlupa to accept, execute and sign the Deed of Donation with the **Department of Health-Metro Manila Center for Health Development (DOH-MMCHID)** represented by Gloria J. Balboa, MD of Four (4) units Ambulance Vehicles including all equipment therein.
