WHEREAS, pursuant to Article 15 of the Implementing Rules and Regulations (IRR) of the Local Government Code of 1991 which states that, **“there is a boundary dispute when a portion or the whole territorial area of a Local Government Unit is claimed by two or more Local Government Units, Boundary disputes between or among Local Government Units shall, as much as possible be settled amicably”;**

WHEREAS, pursuant to Executive Order No. 7, Series of 2014, a Committee on Territorial Boundaries was created which have the following duties and functions, to wit: **to review and compile available legal document/s defining the area or territory of the City of Muntinlupa, by metes and bounds or natural boundaries; conduct geodetic survey to determine possible encroachments by neighboring cities of these identified and established territorial boundaries; and recommend the institution of the appropriate actions to assert and enforce the city of Muntinlupa’s territorial boundaries to the City Mayor;**

WHEREAS, after the creation of the Executive Order No. 7, Series of 2014, the **Committee on Territorial Boundaries** started its preliminary discussions and provided for possible strategies on how to settle the boundary disputes;

WHEREAS, Executive Order No. 35, Series of 2020, was enacted which provides for **the re-composition of the creation of the Committee on Boundaries for the purpose of further amending or modifying the committee brought about by the exigencies of service due to personnel movement/transfer or change in work assignment, to include representation from other pertinent departments/offices;**

WHEREAS, after the enactment of Executive Order No. 35, Series of 2020, and due to the exigencies of the current COVID-19 pandemic, no recurring meeting has yet been convened by the **Committee on Territorial Boundaries;**
