WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Gemwealth Construction & Trading's** its bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **One Million Six Hundred Twenty-Two Thousand Four Hundred Fifty-Five Pesos and 16/100 (Php1,622,455.16)**;


