WHEREAS, on May 26, 2021, the 9th Sangguniang Panlungsod enacted Ordinance No. 2021-236, otherwise known as the as the Supplemental Budget No. 1, amounting to One Billion Two Hundred Million Pesos (Php1,200,000,000.00) for construction/completion of various priority development projects of the City Government;

WHEREAS, the authority given by the 9th Sangguniang Panlungsod to the City Mayor Atty. Jaime R. Fresnedi to enter into a Construction Agreement is based on the documents submitted by the Bids and Awards Committee (BAC);
