WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx the Bids and Awards Committee (BAC) is authorized to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulation (IRR) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances,"

WHEREAS, on May 26, 2021, the 9th Sangguniang Panlungsod enacted Ordinance No. 2021-236, otherwise known as the as the Supplemental Budget No. 1, amounting to One Billion Two Hundred Million Pesos (Php1,200,000,000.00) for construction/completion of various priority development projects of the City Government;

WHEREAS, the authority given by the 9th Sangguniang Panlungsod to the City Mayor Atty. Jaime R. Fresnedi to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project Pipe Laying for Water Supply System located at Lakeview Employees Housing, Barangay Putatan, Muntinlupa City in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS), and City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days:

WHEREAS, in response to the said advertisement, two (2) bidders submitted their letter of intents and application for eligibility and was found eligible on May 11, 2021;

WHEREAS, there is one (1) Bidder who submitted its Bid on May 11, 2021 and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, KME Design & Construction's bid has been responsive to Approved Budget for the Contract (ABC) amounting to Eight Million Three Hundred Fifteen Thousand Seven Hundred Twenty-Nine Pesos and 05/100 (Php8,315,729.05);

WHEREAS, the project was awarded to KME. Design & Construction which is the lowest bidder for the project Pipe Laying for Water Supply System located at Lakeview Employees Housing, Barangay Putatan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with KME. Design & Construction for the project Pipe Laying for Water Supply System located at Lakeview Employees Housing, Barangay Putatan, Muntinlupa City in the amount of Eight Million Eighty-Eight Pesos and 59/100 (Php8,000,088.59) which amount shall be taken from the 2021 Supplemental Budget No.


