**WHEREAS**, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "*The City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance*";

**WHEREAS**, Section 458 of RA 7160 mandates the Sangguniang Panlungsod, as the legislative body of the city, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants and in the proper exercise of the corporate powers of the city shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities;

**WHEREAS**, the Department of Interior and Local Government (DILG), through its Bureau of Fire Protection (BFP) has a "BFP Nurse Deployment Program" where nurse's personnel of the BFD are being deployed in hospitals and health facilities in response to the call of the Department of Health for more health workers to manage COVID-19 cases in the National Capital Region(NCR);

**WHEREAS**, the BFP, for a period of six (6) months will deploy six (6) of its nurse personnel at the City Health Office to augment the latter's health work force under the terms of their engagement and other protocols;
