WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Ayana Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Thirteen Million Sixty-One Thousand Seven Hundred Seventy-Two Pesos (Php13,061,772.00)**;
