A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JADOMINIA CONSTRUCTION & SUPPLIES FOR THE PROJECT CONSTRUCTION OF WASTE COLLECTION AREA LOCATED AT PACWOOD, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION FOUR HUNDRED FIFTEEN THOUSAND ONE HUNDRED FORTY-TWO PESOS AND 50/100 (PHP2,415,142.50) WHICH AMOUNT SHALL BE TAKEN FROM 2021 CONTINUING APPROPRIATIONS FROM 2020 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF)

WHEREAS, the authority given by the 9th Sangguniang Panlungsod to the City Mayor Atty. Jaime R. Fresnedi to enter into a ***Construction Agreement*** is based on the documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Construction of Waste Collection Area** located at **Pacwood, Barangay Tunasan, Muntinlupa City** in the newspaper of general circulation, and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their letter of intents and application for eligibility and was found eligible on **June 29, 2021**;

WHEREAS, there is one (1) Bidder who submitted its Bid on **June 29, 2021** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Jadominia Construction & Supplies's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to Two Million Four Hundred Nineteen Thousand Sixteen Pesos (**Php2,419,016.00**);

WHEREAS, the project was awarded to **Jadominia Construction & Supplies** who being the lowest bidder for the project **Construction of Waste Collection Area** located at **Pacwood, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Jadominia Construction & Supplies** for the project Construction of Waste Collection Area Located At Pacwood, Barangay Tunasan, Muntinlupa City in the amount of Two Million Four Hundred Fifteen Thousand One Hundred Forty-Two Pesos And 50/100 (**Php2,415,142.50**) which amount shall be taken from **2021 Continuing Appropriations from 2020 Executive Budget under 20% Community Development Fund (CDF)**.
