**WHEREAS**, the authority given by the **9<sup>th</sup> Sangguniang Panlungsod** to the **City Mayor Atty. Jaime R. Fresnedi** to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, on February 22, 2021, the 9<sup>th</sup> Sangguniang Panlungsod adopted Resolution No. 2021-452, entitled, "**A resolution endorsing the development of Alabang Viaduct Phase 2, the fund of which shall be provided by the Local Government Support Fund-Assistance to Cities (LGSF-AC) FY 2020 General Appropriations Act, Republic Act No. 11465 under the Green, Green, Green Program of the DBM the cost of Maintenance of the Project shall be provided by the City Government of Muntinlupa**";

WHEREAS, on **May 24, 2021**, Mr. Erwin P. Vibora Acting City Treasurer, certified that the amount of **Fifteen Million Nine Hundred Eighty-Two Thousand Five Hundred Forty-Three Pesos (Php15,982,543.00)** was deposited to the General Fund of the City on **April 19, 2021**;

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Development of Alabang Viaduct (Phase 2) located at Barangay Alabang, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS), and City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their letter of intents and application for eligibility and was found eligible on **June 29, 2021**;

WHEREAS, there is one (1) Bidder who submitted its Bid on **June 29, 2021** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **KME Design & Construction's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to Fifteen Million Nine Hundred Eighty-Two Thousand Four Hundred Forty-Three Pesos and 36/100 (**Php15,982,443.36**);

WHEREAS, the project was awarded to **KME. Design & Construction** which is the lowest bidder for the project **Development of Alabang Viaduct (Phase 2)** located at **Barangay Alabang, Muntinlupa City**;






