WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, CSL Construction Corporation's bid has been responsive to Approved Budget for the Contract (ABC) amounting to Six Million Four Hundred Twenty-Four Thousand One Hundred Sixty-Two Pesos and 97/100 (Php6,424,162.97);

WHEREAS, the project was awarded to CSL Construction Corporation who being the lowest bidder for the project Improvement Works of Muntinlupa Student Center for Life Skill located at Laguerta, Barangay Tunasan, Muntinlupa City;




