A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH V.F. LABAO CONSTRUCTION CORPORATION FOR THE PROJECT WATERPROOFING OF ROOF DECK OF MUNTINLUPA CITY TECHNICAL INSTITUTE (MCTI), BARANGAY PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION TWO HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED FORTY PESOS AND 95/100 (PHP2,269,340.95) WHICH AMOUNT SHALL BE TAKEN FROM 2021 CONTINUING APPROPRIATIONS UNDER INFRA-FUND

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **V.F. Labao Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Two Million Two Hundred Seventy-Nine Thousand Nine Hundred Fourteen Pesos and 74/100 (Php2,279,914.74)**;

WHEREAS, the project was awarded to **V.F. Labao Construction Corporation**, which being the lowest bidder for the project **Waterproofing of Roof Deck of Muntinlupa City Technical Institute (MCTI), Barangay Putatan, Muntinlupa City**;






