FRESNEDI TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF MUNTINLUPA CITY TECHNICAL INSTITUTE (MCTI) WITH THE GOOD JOB MANPOWER SPECIALIST CORP. REPRESENTED BY ITS PRESIDENT MR. AARON NAPIZA FOR THE PURPOSE OF PROVIDING SUPPORT AND ASSISTANCE BY WAY OF REFERRING THE GRADUATES OF AUTOMOTIVE MECHANIC AND OTHER VOCATIONAL TRADES FOR POSSIBLE EMPLOYMENT

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

WHEREAS. Muntinlupa City Technical Institute (MCTI) is duly recognized by the Technical and Skills Development Authority (TESDA) located at San Guillermo, Barangay Putatan, Muntinlupa City;

WHEREAS, *Good Job Manpower Specialist Corp.* is a corporation duly organized and registered under the laws of the Republic of the Philippines herein represented by its President, Mr. Aaron Napiza, of legal age, Filipino, with office address located at #90 Dama de Noche St., Rainbow Village, Las Piñas City;

WHEREAS, the *Good Job Manpower Specialist Corp.* and **MCTI** believe in the advocacy of providing gainful and profitable employment to the vocational graduates, and therefore, the MCTI does not expect any compensation, monetary or anything of value in exchange of the referrals. After all the ultimate goal of **MCTI** is for its graduates to land in jobs which are financially rewarding;

WHEREAS, under the Memorandum of Agreement (**MOA**) the Muntinlupa City Technical Institute (**MCTI**) will refer its vocational course graduates to the *Good Job Manpower Specialist Corp.* for free basic orientation and possible employment;

WHEREAS, if the graduates are hired, no placement fees shall be collected from the graduates and no deduction shall be made from salary;

WHEREAS, the City Government of Muntinlupa and the *Good Job Manpower Specialist Corp.* shall undertake the Memorandum of Agreement (**MOA**) for the purpose of providing, support and assistance to the Establishment (*Good Job Manpower Specialist Corp.*) by way of referring the graduates of auto mechanic and other vocational trades for possible employment;

WHEREAS, the City Legal Office has no objection to the Memorandum of Agreement (**MOA**) provided that, the Data Privacy Act shall be observed;

WHEREAS, the contract shall be for one (1) year or twelve (12) months from the date of signing of the contract;

WHEREAS, after the expiration of the period, an assessment/evaluation must be made to determine the number of graduates successfully placed or hired through the agency before the renewal of the contract;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi** to enter and sign the **Memorandum of Agreement (MOA)** in behalf of the **Muntinlupa City Technical Institute (MCTI)** between the **Good Job Manpower Specialist Corp.** represented by its **President, Mr. Aaron Napiza** for the purpose of providing support and assistance by way of referring the graduates of automotive mechanic and other vocational trades for possible employment.

RESOLVE FURTHER, that the suggestions of the City Legal Office shall be incorporated to the Memorandum of Agreement (**MOA**).
