WHEREAS, the mandate of the **Committee on Personnel Administration** under Rule VIII (s) of the Internal Rules of Procedure for the 9th **Sangguniang Panlungsod of Muntinlupa** to confirm all appointments made by the Honorable City Mayor is derived from **Article III, Section 8(d) of Republic Act 7926**, otherwise known as the "**City Charter of Muntinlupa**" which provides as follows:

"Unless otherwise provided herein, all appointed city officials of the City shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod Members, subject to Civil Service Law, Rules and Regulations. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, "In compliance to Memorandum Circular 14, s. 2018, pertaining to all heads of constitutional bodies departments, bureaus and agencies of the national government units: Government-Owned or Controlled Corporation (GOCC) with charters; and **State Universities and Colleges.**" provides:

"2017 Omnibus Rules on Appointment and Other Human Resource Actions, revised July 2018". In CSC Resolution No. 1701009 dated June 16, 2017 Omnibus Rules on Appointment and Other Human Resource Actions (ORAOHRA) to govern the preparation, submission of, and actions to be taken on appointments and other human resource movements in the Philippine government."

To ensure that provisions of policy are in accordance with other administrative issuances and pertinent laws, and to respond to the changing needs in human resource management, the Commission, pursuant to CSC Resolution No. 1800692 dated July 3, 2018, approved the amendments and additional provisions to the 2017 Omnibus Rules on Appointments and Other Human Resource Action (ORARHA.)”

WHEREAS, the *Hon. City Mayor Atty. Jaime R. Fresnedi*, as the appointing authority, has recommended the appointment of *Dr. Raymundo Panganiban Arcega* as *City Government Department Head II* at the *Pamantasan ng Lungsod ng Muntinlupa (Office of the University President)* of the City Government of Muntinlupa and has submitted the same for the *confirmation* by the City Council;

WHEREAS, *Dr. Raymundo Panganiban Arcega*, finished his college level at the *Far Eastern University* with the degree of *Bachelor of Arts in Political Science* in 1987-1994 and *Manuel L. Quezon University of Law*, with the degree of *Bachelor of Laws* in 1992;

WHEREAS, *Dr. Raymundo Panganiban Arcega*, finished his Graduate Studies at the *Ateneo De Manila University* with the degree of Master in *Business Administration* in 2005-2007 and *Polytechnic University of the Philippines* with the degree of *Doctor in Business Administration* in 2007-2013.

WHEREAS, on February 11, 2015, *Dr. Raymundo Panganiban Arcega*, passed the examination for license *Career Executive Service Eligibility* by the Career Executive Service Board with CESB Res. 1200. He also passed the Civil Service Examination, Sub-Professional and Professional, respectively.

WHEREAS, *Dr. Raymundo Panganiban Arcega* was appointed to the following:

- January 7, 1990 to June 30, 1993 - **Faculty**, at FEU Institute of Accounts, Business and Finance;
- July 1, 1993 to July 1, 1995 – **Clerk III** – Regional Trial Court, Manila;
- July 6, 1997 to February 3, 1997 – **Part-Time Instructor**, Pamantasan ng Makati;
- March 3, 1997 to May 1, 2006 – **Human Resource Management Officer II** – University of Makati;
- January 5, 2006 to April 30, 2013 – University of Makati;
- May 1, 2013 to July 1, 2019 – **City Assistant Department Head II** (EVP Designate) – University of Makati;
- July 1, 2019 to November 3, 2019 – **Full Professor** – University of Makati;
- June 16, 2020 up to Present – **Chancellor** - Lyceum of the Philippines University;

WHEREAS, there is a need for the confirmation of appointment of *Dr. Raymundo Panganiban Arcega*, to legally discharge his duties, functions, and responsibilities as *City Government Department Head II* at the *Pamantasan ng Lungsod ng Muntinlupa (Office of the University President)* of the City Government of Muntinlupa;

WHEREAS, based on the documents submitted and verifications made by City Human Resource and Management Department during the public hearing, *Dr. Raymundo Panganiban Arcega*, is qualified for the appointment and position as *City Government Department Head II* at the *Pamantasan ng Lungsod ng Muntinlupa (Office of the University President)* of the City Government of Muntinlupa;
