WHEREAS, Section 22(a) (5) of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991 provides that, "Every local government unit, as a corporation, shall have the power to enter into a contract";

WHEREAS, Section 22(c) of the same Code further provide that, "Unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned";

WHEREAS, Section 35 of LGC allows Local government units to enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services;

WHEREAS, Benby Enterprises, Inc., represented by its CEO and President Jamie Elaine Y. Tan, is a duly registered corporation with the office address at 216 Banawe Street, Barangay Manresa, District 1, Quezon City Philippines, and which warehouse is located at Km. 23 East Service Road, Barangay Cupang, Muntinlupa City, promotes its Benby Vaccination Program where the excess vaccines procured by the company will be turned over to the City Government to help in the LGU's vaccination undertakings;

WHEREAS, through coordination with the City Health Office, the donated vaccines shall be dispensed to the New Cupang Health Center which is in close proximity to Benby's warehouse ensuring the requirement in the cold-chain of vaccines;
