A RESOLUTION ADOPTING THE RECOMMENDATION OF THE BLUE RIBBON COMMITTEE DISMISSING SP ADMINISTRATIVE CASES NUMBER 2021-001 AND 2021-002 RELATING TO THE COMPLAINTS FILED BETWEEN SANGGUNIANG KABATAAN (SK) CHAIRMAN JAN NHETTE AHYA C. DANCEL AND SANGGUNIANG KAGAWADS ERWIN L. SANTOS, KARL ERICSON N. LANDRITO, MA PATRICIA ANN LIZARDO, RAVENN B. MIRANDA AND JACQUELINE NICOLE GALEON, ALL OF BARANGAY ALABANG, MUNTINLUPA CITY AND DENYING ANY FURTHER COMPLAINT WHICH MAY ARISE FROM THE SAME TRANSACTION

WHEREAS, the Sangguniang Panlungsod in the exercise of its quasi-judicial function shall act on complaints filed against elective barangay official and pursuant to *Administrative Order 23 series of 1992 and pertinent provisions of the Local Government Code of 1991, as disciplinary authority, may impose preventive suspension on erring official;*

WHEREAS, Section 32 of the **Internal Rules of Procedure (IRP)** of the 9<sup>th</sup> Sangguninan vests unto the **Committee on Blue Ribbon** matters related to investigation of malfeasance, misfeasance, and nonfeasance in office by barangay officials among others;

WHEREAS, on September 16, 2021, a verified complaint was filed by SK *Chairman Jan Nhette Ahya Dancel* against *SK Kagawads Erwin Santos Karl Ericson N. Landrito, Ma Patricia Ann Lizardo, Ravenn B. Miranda And Jacqueline Nicole Galeon* for violation of Section 8(b), Section 9 (a), all in relation to Section 18 (a) (d) (h), of R.A. 10742, Grave Misconduct, or in the Alternative, Gross Neglect in the Performance of Duty, Violation of the Internal Rules of the SK Alabang, and Violation of R.A. 6713 (Code of Conduct and Ethical Standards of Public Official (docketed as SP Admin Case No 2021-001);

WHEREAS, Respondents in SP Administrative Case No. 2021-001 were able to file their answer on **October 8, 2021**, complainant on the other hand filed her reply on October 18, 2021;

WHEREAS, the issues having been joined, the **Committee on Blue Ribbon** had its **Pre-Hearing Conference** on **October 28, 2021** parties to appear, consider and agree on any of the following: Stipulation of facts; Simplification of issues; identification and marking of evidence of the parties; Waiver of objections to admissibility of evidence; Limiting the number of witness and their names; Dates of subsequent hearings; and such other matters as may aid in the prompt and just Resolution of the case;

WHEREAS, during the pre-hearing conference, it was found out, aside from the lack of Certification against forum shopping, that the allegations in the answer submitted by the respondents partake the nature of a permissive counterclaim and being as such may not be entertained by the Committee in accordance with the Internal Rules of Procedure that mandates only Compulsory counterclaim, hence the postponement;

WHEREAS, on **November 8, 2021**, **SK Kagawads Erwin Santos Karl Ericson N.Landrito, Ma Patricia Ann Lizardo, Ravenn B. Miranda And Jacqueline Nicole Galeon** filed a complaint against **SK Chairperson Jan Nhette Ahya Dancel** for Violation of pertinent provisions of Section 4 (a) and 7(a) of R.A. 6713 (Code of Conduct and Ethical Standards of Public Official and Employees; and Section 3 (i) and 4(a) of RA 3019 of the Anti-Graft and Corrupt Practices Act (docketed as SP ADMIN CASE 2021-002);

WHEREAS, respondent **Dancel** in **SP ADMINISTRATIVE CASE 2021-002** was able to file her answer. The Committee thence held a pre-trial hearing conference on November 16, 2021 for both **SP ADMINISTRATIVE CASES 2021-001 and 2021-002**;

WHEREAS, in the said pre hearing conference, parties to SP Administrative Cases No. 2021-001 and 2021-002, through their respective counsels, manifest their resolution to voluntarily withdraw the complaints filed;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to adopt the recommendation of the **Blue Ribbon Committee** dismissing **SP Administrative Cases Number 2021-001 And 2021-002** relating to the complaints filed between Sangguniang Kabataan (SK) Chairman **Jan Nhette Ahya C. Dancel And Sangguniang Kagawads Erwin L. Santos, Karl Ericson N. Landrito, Ma Patricia Ann Lizardo, Ravenn B. Miranda And Jacqueline Nicole Galeon**, All of Barangay Alabang, Muntinlupa City, and **denying any further complaint arising from the same transaction**.
