WHEREAS, Section 455 of Republic Act 7160 of the Local Government Code of 1991, *empowers the city mayor, as chief executive of the city government, to exercise such powers and perform such duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;*

WHEREAS, pursuant to the powers granted under RA 7160, otherwise known as the Local Government Code of 1991, *"The city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";*

WHEREAS, Development Bank of the Philippines (DBP), a government financial institution created and operating pursuant to the provision of Executive Order No. 81, otherwise known as the 1986 Revised Charter of the Development Bank of the Philippines, as amended by Republic Act No. 8523 dated February 14, 1998 with principal office at Sen. Gil Puyat Ave., corner Makati, Makati City with a Branch Office at Doña Amparo Building, #34 National Road, Barangay Putatan, Muntinlupa City;

WHEREAS, DBP is the repository of fund for the payroll of Regular Employees and a partner of the City Government of Muntinlupa (CGM) in various banking needs such as salary loan, merchant agreement point of sale and Internet Payment Gateway for the Service Online Payment of Citizens/Clients of taxes and fees;

WHEREAS, with DPB as one of the government financing institutions, the client base of the bank is mostly national government entities in addition to the private citizens who uses the single Automated Teller Machines (ATM) located in its branch;

WHEREAS, the additional ATM to be placed within the premises of the CGM would alleviate the volume of persons availing of the facility especially during paydays and would give additional access for the employees and officers of the City;

WHEREAS, the City Legal Office (CLO) interposes no objection on the provisions stipulated under the MOA, which include among others the obligation of the CGM:

- a) *Term of one year*
- b) *Area of 10 square meters*
- c) *Provision by the CGM of lighting and electrical facility*

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter and sign the Memorandum of Agreement (**MOA**) in behalf of the City Government of Muntinlupa (**CGM**) with Development Bank of the Philippines (**DBP**) represented by its Branch Banking Group Head **Ms. Adeleine F. Aldana** on the installation of one (1) unit Automated Teller Machine (**ATM**) within the premises of Muntinlupa City Hall.
