WHEREAS, Article 86 (b) (1) (vi) and Article 86 (b) (1) (viii) of the LGC of 1991, provides that, "The City Mayor shall represent the' City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that. "xxx No contract may be entered into by the Local Chief Executive in behalf of the Local Government unit without prior authorization by the Sangguniang concerned"

WHEREAS, the Home Development Mutual Fund (PAG-IBIG) is a government financial institution duly organized and existing under and by virtue of Republic Act No. 9679 with principal address at 42/F, Petron Mega Plaza, 358 Sen. Gil Puyat, Avenue Makati City represented by its Vice President for Member Services Operations – NCR South West Group, Erlinda M. Francisco;

WHEREAS, pursuant to RA 9679, PAG-IBIG'S fund objective to provide small and short term loans (STL) and other benefits assistance program to its members consistent with its provident fund character, access to STL may be done through the Online STL by enrollment of applicant-member in the application through Virtual Pag-Ibig;
