**A RESOLUTION URGING ALL BARANGAYS IN MUNTINLUPA CITY TO DESIGNATE A BARANGAY FOCAL PERSON FOR PERSONS WITH DISABILITY (BFPPWD) WHO SHALL BE THE COORDINATING ARM OF THE MUNTINLUPA CITY PERSONS WITH DISABILITY AFFAIRS OFFICE (MCPDAO)**

WHEREAS, Art. III, Section 11, of the 1987 Constitution provides that, *"The State shall adopt an Integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all people of affordable cost and that priority shall be given for the needs of the underprivileged, sick, elderly, disabled. Women and children"*;

WHEREAS, Section 40(b) (1) of Republic Act No. 7277, as amended by Republic Act No. 10070, *requires the organization and establishment of a Persons with Affairs Office (PDAO) in all local government units which shall be the lead office in the enhancement of the health, physical fitness and economic well-being of Persons with Disabilities (PWDs) within the territorial jurisdiction of the establishing local government;*

WHEREAS, on May 21, 2018, the 8<sup>th</sup> Sangguniang Panglungsod enacted Ordinance No. 18-167, otherwise known as, *"An ordinance organizing and establishing the Muntinlupa City Persons with Disability Affairs Office (MC-PDAO) in accordance with Section 40(b) (1) of Republic Act No. 7277, otherwise known as the "Magna Carta for Persons with Disability, as amended by Republic Act No. 9442 And Republic Act 10070"*;

WHEREAS, as per *Local Budget Memorandum No. 67* dated June 28, 2013 of The Department of Budget and Management (DBM) *"LGUs shall likewise include PPAs that can be attributed and built-in within the budget level for the following Persons with Disabilities pursuant to Republic Act 7277"*;

WHEREAS, in order to intensify the full implementation of **City Ordinance 18-167**, especially at the **Barangay Level**, and ensure consideration of **DBM Memorandum No. 67** in the LGU Budget process there is a need to designate a Focal Person for Persons with Disability (**BFPPWD**) to serve as **coordinator** with the Muntinlupa City Persons with Disability Affairs Office (**MC-PDAO**);

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **9<sup>th</sup> Sangguniang Panglungsod of Muntinlupa**, to urge, all **nine (9) Barangays** in Muntinlupa City to designate a Barangay Focal Persons for Persons with Disability (**BFPPWD**) to serve as coordinator with the Muntinlupa City Persons with Disability Affairs Office (**MC-PDAO**);

RESOLVED FURTHER, that the **Barangays** shall be guided by the following guidelines in the appointment/ designation of BFPPWD:

A. FUNCTIONS:

1. *Implement policies, plans, and program for the promotion of the welfare of PWDs in coordination with MC-PDAO;*
2. *Serve as PWD Affairs advocate in the barangay;*
3. *Recommend and enjoin the participation of non-government organizations and people's organizations in the implementation of all disability-related laws and policies;*
4. *Submit an annual plan of activities for inclusion in the budgetary allotment for review and approval of the Sangguniang Barangay as per DBM Local Budget Memorandum No. 67 pursuant to R. A. No. 7277;*
5. *Act as advisor to the Punongbarangay and community officials on matters concerning PWDs;*
6. *Gather and compile relevant data on PWDs in the barangay;*
7. *Disseminate information including, but not limited to, programs and activities for PWDs including children with disability, and training and employment opportunities for PWDs;*
8. *Participate in various trainings, conferences, summits, as part of the programs of the Muntinlupa City government through MC-PDAO or other private organizations for capacity building and continuous education on PWD issues;*
9. *Submit reports to the Punongbarangay on a regular basis with regards to the implementation of programs and services to PWDs and furnish a copy of such to the MC-PDAO;*

**B. QUALIFICATIONS OF THE BFPPWD:**


1. *Preference towards a member of a PWD organization based in the barangay where he/she will be designated;*

5. *Must be employed by the barangay*


**RESOLVED FINALLY**, that a copy of this resolution be furnished to **nine (9) Barangays** of this City.


