WHEREAS, Section 455 (b)(1) Xvi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"The City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance"**;

WHEREAS, **Philippine Veterans Bank (PVB)** is a private commercial banking corporation and Authorized Government Depository Bank (**AGDB**) duly organized and existing under and by virtue of the Philippine Laws with office address at the **PVB Building, 101 V.A. Rufino corner Dela Rosa Streets, Legaspi Village Makati City**;

WHEREAS, by virtue of Sanggunian Panlungsod **Ordinance No. 17-076**, Colegio de Muntinlupa (CDM) was established with its staffing and personnel organization likewise defined in the same ordinance as amended;

WHEREAS, for services rendered, employees and faculty members of the **CDM** were compensated through a payroll facility provided by the Philippine Veterans Bank;

WHEREAS, the CDM wishes to avail of a systematized payroll services to meet its payroll requirements, and thereby provide its employees with an efficient and secure mode of withdrawing their salaries and wages;

WHEREAS, on August 15, 2012, **Republic Act No. 10173**, otherwise known as the **Data Privacy Act** was signed into a law which seeks to protect all forms of information, be it private, personal, or sensitive;

WHEREAS, Republic Act 10173 provides that, **"The processing of personal information shall be allowed, subject to compliance with the requirements of the Data Privacy Act and other laws allowing disclosure of information to the public and adherence to the principles of transparency, legitimate purpose and proportionality"**;

WHEREAS, to comply with the general data privacy principle and its implementing rules and regulations, there is a need to include the data privacy and confidentiality provision in the payroll facility and services agreement of part time employees of the CDM;

WHEREAS, the PVB shall provide the CDM with automatic payroll facility and services with the use of an ATM card and ATM payroll account;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to represent Muntinlupa in a **Memorandum of Agreement (MOA)** with **Philippine Veterans Bank (PVB)** represented by its **Senior Vice President and Branch Banking Group Head, Edwin T. Amahan** for the inclusion of the Data Privacy and Confidentiality Provision in the Payroll Facility and Services of Employees of Colegio De Muntinlupa (CDM).
