



WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project completion works for the construction of track and field located at Sports Complex, Barangay Tunasan, Muntinlupa City in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, D.L. Cervantes Construction Corporation's bid has been responsive to Approved Budget for the Contract (ABC) amounting to Thirty-Four Million Four Hundred Nineteen Thousand Twenty-Six Pesos and 90/100 (Php34,419,026.90);

WHEREAS, the project was awarded to D.L. Cervantes Construction Corporation who being the lone bidder for the project completion works for the construction of track and field located at Sports Complex, Barangay Tunasan, Muntinlupa City;
