WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project construction **Colegio De Muntinlupa Building 2 (Phase 3)** located at **Barangay Sucat, Muntinlupa City** in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;






