WHEREAS, Section 22 (a) (4) and (5) of the Local Government Code states that, "Every local government unit, as a corporation, shall have the following powers: xxx (4) To acquire and convey real and personal property; (5) To enter into contracts xxx;"

WHEREAS, pursuant to Joint Memorandum Circular 2021- 002 or the "Operational Guidelines for the Donation and Subsequent Reallocation of Privately Procured COVID-19 Vaccine Doses to the National Government, Local Government Units and other private sector Entities," of the National Task Force (NTF)- Department of Health (DOH), private sectors with unutilized or excess doses may donate the same to the national government or to a Local Government Unit (LGU);

WHEREAS, the Implementing Rules and regulations of Republic Act 11525, otherwise known as the An Act Establishing The Coronavi: us Disease 2019 (Covid-19) Vaccination Program Expediting The Vaccine Procurement And Administration Process, Providing Funds Therefor, And For Other Purposes states that, "The LGUs may directly accept donations of FDA-approved and cleared Covid-19 vaccines, subject to the guidelines and reportorial requirements of the DOH and the NTF, which gives priority needs of the following groups: healthcare workers, senicr citizens, persons with comorbidities, frontline personnel in essential services, and the indigent population, in the order indicated in those guidelines."

WHEREAS, Pepsi Cola Philippines, Inc., have procured doses of Astra Zeneca vaccines for the use of its personnel but due to the delay in the delivery of said vaccines, the efficient inoculation program of the City Government was extended to their workers, thence, an oversupply or excess of the company's needed vaccines:
