WHEREAS, the authority given by the 9th Sangguniang Panlungsod to the **City Mayor Atty. Jaime R. Fresnedi** to enter into a **Construction Agreement** is based on the documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **construction of Perimeter Fence at Victoria Elementary School** located at **Victoria Homes, Barangay Tunasan, Muntinlupa City** in the newspaper of general circulation, and likewise posted at the Government Electronic Procurement System (GEPS), City's Website and at the same conspicuous place the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Jadominia Construction & Supplies's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Two Million Four Hundred Nine Thousand Three Hundred Fifty-One Pesos and 874/100 (Php2,409,351.84)**;
