A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH POWER TECHNOLOGIES, INC. WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Waste Water Treatment Facility & Rain Water Recovery System located at Employees Housing Lakeview, Barangay Putatan, Muntinlupa City** in the newspaper of general circulation, and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, one (1) bidder submitted its letter of intent and application for eligibility and was found eligible on **November 4, 2021**;

WHEREAS, there is one (1) Bidder who submitted its Bid on **November 4, 2021** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Power Technologies, Inc.'s** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Thirty-Seven Million Three Hundred Sixty-Seven Thousand Three Hundred Fifty-Seven Pesos and 29/100 (Php37,367,357.29)**;

WHEREAS, the project was awarded to **Power Technologies, Inc.** who being the lowest bidder for the project **Waste Water Treatment Facility & Rain Water Recovery System located at Employees Housing Lakeview, Barangay Putatan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Power Technologies, Inc.** for the project **Waste Water Treatment Facility & Rain Water Recovery System located at Employees Housing Lakeview, Barangay Putatan, Muntinlupa City** in the amount of **Thirty-Seven Million Three Hundred Sixty Thousand Pesos (Php37,360,000.00)** which amount shall be taken from Supplemental Budget No. 2 under the 20% Community Development Fund (CDF).
