WHEREAS, Article II Section 15 of the Philippine Constitution states, "The State shall protect and promote the right to health of the people and instill health consciousness among them.";

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants;

WHEREAS, Presidential Decree 491 of 1974 or the *Nutrition Act of the Philippines* created the *National Nutrition Council (NNC)* to supervise, coordinate and evaluate the implementation of the national nutrition program which shall be implemented by all agencies and instrumentalities of both the government and the private sector;

WHEREAS, on December 3, 2009, the NNC Governing Board approved Resolution No. 1 Series of 2009 Adopting a Policy on Nutrition Management in Emergencies and Disasters which shall apply to all sectors, whether government, nongovernment or private institutions whose functions and activities contribute to the prevention of a deterioration in the nutritional status of Filipinos particularly the most vulnerable groups: infants, children, pregnant women and breastfeeding mothers, older persons, people with disabilities, and people living with debilitating conditions during emergencies and disasters;

WHEREAS, the NCC Resolution will serve as guide of LGUs in preparing and managing the food and nutrition situation in times of emergencies and disasters at various stages: early, intermediate and extended emergency and shall set the directions on strategies for nutrition management in emergencies and disasters particularly on planning, surveillance, rapid nutritional assessment, and implementation of nutrition interventions at various stages;
