WHEREAS, Section 25 (b) of Republic Act 7160 also known as the Local Government Code, provides that, **“National agencies and offices with project implementation functions shall coordinate with one another and with the local government unit concerned in the discharge of their functions. National agencies shall ensure the participation of local government units both in the planning and implementation of national projects”**;

WHEREAS, the DPWH proposed the project entitled **Network Development- Construction of Missing Links /New Roads (C6)-Laguna lake highway extension (Phase 1 and 2)** where the affected barangay is Sucat, Muntinlupa City;

WHEREAS, on **August 13, 2021** in a communication signed by **OIC Juby Cordon** of the Office of the Regional Director to the City Mayor, DPWH informed Mayor Fresnedi that the scope of works in the project to be implemented in the given period will be embankment, boulder fill and pipe culverts;

WHEREAS, on **December 21, 2021**, a coordination meeting/public hearing was held at **Barangay Sucat** but the **City Engineer** deemed it proper to elevate the discussion to the Sangguniang Panlungsod citing, **“(the) project requires more intensive and broader discussion and public hearing involving the City Council to further assess the legal, structural framework and viability of the said undertaking”**;





ADOPTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 27th day of December 2021, on its 129th Regular Session.


