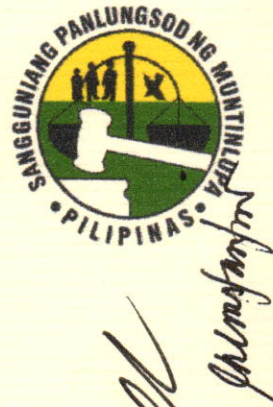

WHEREAS, Rolando Aureo Gutierrez Andaya Jr., born March 10, 1969, was a Filipino lawyer and politician who served as a member of the House of Representatives of the Philippines where he represented the 1st district of Camarines Sur from 1998 to 2006 and again from 2010 to 2019. During his stint in the Congress, he was a House Deputy Speaker from 2016 to 2018 in the 17th Congress and later he then served as the House Majority Leader from 2018 to 2019;

WHEREAS, the late Congressman Andaya served the Executive Department as the Secretary of Budget and Management from 2006 to 2010 in President Gloria Macapagal Arroyo's cabinet where, in his capacity as such, several budget allocations were granted to the City of Muntinlupa namely; the construction of Hall of Justice at Tunasan, construction of Muntinlupa City Hall Main Building after it was razed by fire in 2007 and the Bahay Alumni at the Muntinlupa National High School;

WHEREAS, the late Congressman Andaya was a compassionate and visionary leader who earned the love and trust of his constituents his congressional district in Camarines Sur where volunteers initiated the Laban Mo, Laban Ko a non-profit and not sponsored page created an organization supporting genuine change in the province;
