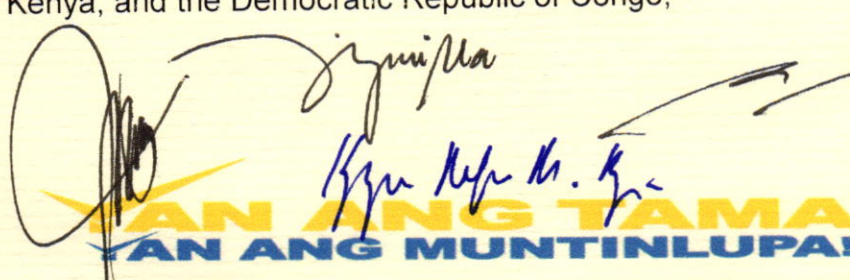

WHEREAS, Article 85 (b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "*(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control at programs, projects, services and activities of the City, and in this connection, shall (vi) represent the city in all its business transactions and sign in its behalf bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.*";

WHEREAS, the World Health Organization's 2021 Global TB Report lists the Philippines as one of 30 high TB-burden countries, with the highest TB incidence rate in Asia at 539 cases per 100,000 people;

WHEREAS, the United States government, through the United States Agency for International Development (USAID), donated a package of new tools to support better tuberculosis (TB) services in the Philippines. The Philippines is one of seven countries selected to receive the iNTP package along with Indonesia, Bangladesh, Vietnam, Nigeria, Kenya, and the Democratic Republic of Congo;

WHEREAS, under the terms and conditions set in the MOA, the City Government shall effectively and efficiently provide quality clinical and laboratory services necessary for the implementation of the iNTP through the Sucat Health Center;

WHEREAS, the MOA shall be effective upon execution of the parties with the initial phase beginning at October 01, 2021 to September 30, 2022;

NOW THEREFORE, BE RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Rozzano Rufino B. Biazon** to represent the City Government of Muntinlupa in a Memorandum of Agreement (MOA) with the **Department of Health-Metro Manila Center for Health Development (DOH-MMCHD)** represented by **Gloria J. Balboa, MD Director IV**, on the **Introduction of New Tool Project (iNTP)** including the equipment, medical or fixed asset, supplies and other properties pertinent to iNTP.
