WHEREAS, Section 45 of Republic Act 7160 otherwise known as the Local Government Code (LGC) of 1991 provides, "Permanent vacancies in the Sanggunian where automatic successions xxx do not apply shall be filled by appointment by x-x-x The city or municipal Mayor, in the case of Sangguniang Barangay, upon recommendation of the Sangguniang Barangay concerned";

WHEREAS, the LGC defined "a permanent vacancy arises when an elective local official fills a higher vacant office, refuses to assume office, fails to qualify, dies, is removed from office, voluntarily resigns, or is otherwise permanently incapacitated to discharge the functions of his office";

WHEREAS, on July 5, 2022, a letter of irrevocable resignation stating the incapacity of Kagawad Christopher L. Arevalo to discharge his duties due to medical reasons was received by Barangay Cupang and accepted by the Barangay Chairman Rainier Emmanuel B. Bulos;

WHEREAS, to prevent vacancy and disenfranchisement of the constituents of Cupang, the Sangguniang Barangay adopted in its Special Session on July 5, 2022, Barangay Resolution 089-2022 recommending CHARLES ANGELO CALIMLIM AREVALO to fill the void in the position of Kagawad ng Barangay;
