BIAZON, ON BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH EVERY NATION CAMPUS-ALABANG (ENC ALABANG), REPRESENTED BY ITS CAMPUS DIRECTOR, SALVADOR JUAN F. DEPANTE III, ON THE PARTICIPATION OF SCHOLARS AND BENEFICIARIES UNDER THE MUNTINLUPA SCHOLARSHIP DIVISION IN THE TRAININGS, SEMINARS, AND ACTIVITIES OF THE ENC ALABANG

WHEREAS, Section 13, Article II of the 1987 Philippine Constitution on the Declaration of Principles and State Policies, states that "The State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;"

WHEREAS, Section 23, supra, provides that "The State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation;"

WHEREAS, Section 2(3), Article XIV of the 1987 Constitution, on Education, states that "The State shall establish and maintain a system of scholarship grants, student loan programs, subsidies, and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged;"

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 455 (b)(1)(vi) of the LGC states that *“The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;”*

WHEREAS, Article 47(a), Rule IX of the Implementing Rules and Regulations of the LGC on the Corporate Powers and Corporate Seal of the Local Government Unit, provides that *“Unless otherwise provided in the Code, no contract may be entered into by the Local Chief Executive in behalf of the LGU without prior authorization by the Sanggunian;”*

WHEREAS, Article 86(b)(1)(vi), supra, provides that *“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;”*

WHEREAS, the City Government of Muntinlupa (CGM) is a local government unit with address at National Road, Barangay Putatan, Muntinlupa City represented by its Chief Executive, **Hon. Rozzano Rufino B. Biazon;**

WHEREAS, the education of our children is one of the top priorities in the “7k Agenda” under *“Karunungan”* of **City Mayor Rozzano Rufino B. Biazon,** his administration;

WHEREAS, the City Government of Muntinlupa, through the Muntinlupa Scholarship Division (MSD), aims to stimulate, encourage and uphold its objectives to prepare the students for a better life in the future and serves as role models of their generation-physically, mentally, socially, morally and spiritually. It extends educational and financial support to those who cannot afford to pay for their education but willing to finish their studies and those who excel academically in school;

WHEREAS, Every Nation Campus-Alabang (ENC Alabang) is a global campus that is passionate about preparing students for LIFE as they believe that the next generation are nation builders and world changers. ENC achieves this by teaching and coaching the students in the areas of Leadership, Integrity, Faith and Excellence or LIFE.

WHEREAS, the CGM and the ENC would like to partner with each other in order to make the trainings, workshops, seminars, activities and other specialized events to be conducted by ENC Alabang be available to the scholars of MSD to give them the benefit of accumulating specified number of hours for their community service in accordance with the Ordinance No. 2020-054 and its Implementing Rules and Regulations;

WHEREAS, the **City Legal Office**, upon review of the MOA, *interpose no objection to the MOA as the same is consistent with the Implementing Rules and Regulations of Ordinance No. 2020-054, which provides that the beneficiaries of MSD are obliged to render community service and participate in activities for their welfare and development;*

WHEREAS, the **City Legal Office**, further emphasize that *the MOA be non-exclusive such that MSD has the liberty to contract with other institutions for the same purpose and objective, and should serve only as an option for the scholars to comply with the Ordinance No. 2022-351;*

NOW THEREFORE, BE IT RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, on behalf of the City Government of Muntinlupa, to enter into and sign a Memorandum of Agreement (MOA) with **Every Nation Campus-Alabang (ENC Alabang)**, represented by its **Campus Director, Salvador Juan Depante III**, on the participation of scholars and beneficiaries under the **Muntinlupa Scholarship Division (MSD)** in the Trainings, Seminars, and Activities of the ENC Alabang.

RESOLVE FURTHER, that copy of this Resolution be given to the parties involved in this **Memorandum of Agreement (MOA)** and other concerned offices/parties, as applicable.
