WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 455 (b)(1)(vi) of the LGC states that, "The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;"

WHEREAS, Section 33 of the Government Accounting Manual for Local Government Units issued by the Commission on Audit (COA) provides, "Local treasurer shall maintain depository accounts in the name of their respective local government units with authorized government depository banks, located in or nearest to their respective areas of jurisdiction. Earnings of its depository accounts shall accrue exclusively thereto."

WHEREAS, the Bureau of Local Government Finance (BLGF) issued Memorandum Circular (MC) No. 07-01-2017 which provides for the amended guidelines on Authorized Government Depository Banks (AGDBs), defined therein as banks where LGUs are allowed to deposit government funds and maintain depository account;

WHEREAS, the **City Government of Muntinlupa**, a government unit duly organized and existing under the laws of the Republic of the Philippines, with principal office at Muntinlupa City Hall, National Road, Barangay Putatan, Muntinlupa City maintains account/s with the DPB;

WHEREAS, the **Honorable Mayor Rozzano Rufino B. Biazon**, duly sworn in as the new local chief executive of the City of Muntinlupa, should be one of the authorized signatories to the account/s being maintained in the DBP;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10<sup>th</sup> Sangguniang Panglungsod**, to authorize the **Hon. Mayor Rozzano Rufino B. Biazon** to be one of the signatories in all the business engagement/accounts of the **City Government of Muntinlupa** with **Development Bank of the Philippines (DBP)**.

RESOLVED FURTHER, that the selection of the DBP as contracting party shall be specified and included in the MOA to be signed by the Local Chief Executive.
