WHEREAS, in response to the said advertisement, two (2) bidders submitted their letters of intent and applications for eligibility and were found eligible on June 21, 2022;

WHEREAS, there is one (1) Bidder who submitted its Bid on June 21, 2022 and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, Jadominia Construction & Supplies's bid has been responsive to Approved Budget for the Contract (ABC) amounting to (*Php4,390,468.83*);

WHEREAS, the project was awarded to Jadominia Construction & Supplies who being the lowest bidder for the project construction of *drainage system and road* located at Bagong Umaga Ilaya St., Barangay Alabang, Muntinlupa City;


