WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **construction of drainage system and road** located at **Bagong Umaga Ilaya St., Barangay Alabang, Muntinlupa City** in the newspaper of general circulation, and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their letters of intent and applications for eligibility and were found eligible on **June 21, 2022**;

WHEREAS, there is one (1) Bidder who submitted its Bid on **June 21, 2022** and passed the Preliminary Examination of Bid at the City Administration Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Jadominia Construction & Supplies's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **(Php4,390,468.83)**;

WHEREAS, the project was awarded to **Jadominia Construction & Supplies** who being the lowest bidder for the project construction of **drainage system and road** located at **Bagong Umaga Ilaya St., Barangay Alabang, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> **Sangguniang Panlungsod**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, on behalf of the City Government of Muntinlupa to enter and sign the Construction Agreement (CA) with **Jadominia Construction & Supplies** for the project construction of **drainage system and road** located at **Bagong Umaga Ilaya St., Barangay Alabang, Muntinlupa City** in the amount of **Four Million Three Hundred Eighty-Two Thousand Four Hundred Ninety-Seven and 38/100 (Php4,382,497.38)** which amount shall be taken from **2022 Executive Budget** under **Infra Fund**.
