AN ORDINANCE GRANTING FINANCIAL ASSISTANCE OF THIRTY THOUSAND PESOS PER FAMILY OR AN AGGREGATE AMOUNT OF ONE HUNDRED TWENTY PESOS (PHP120,000.00) TO THE FOUR (4) FAMILIES WHO PERISHED IN A FIRE ON DECEMBER 18, 2022 AT NO. 2801 LARBAF STREET, BRUGER SUBDIVISION, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that **“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”;

WHEREAS, on **December 18, 2022 at 8:50 a.m.**, a fire broke out at **No. 2801 Larbaf Street, Brugger Subdivision, Barangay Putatan, Muntinlupa City** which gutted structures, displaced families and brought casualties;

WHEREAS, the Social Services Department rendered its initial disaster report dated Dec 19, 2022 which indicated the following assessment: **“One (1) residential and one (1) establishment were damaged during the fire incident affecting four (4) families or eleven (11) individuals. Unfortunately, ten (10) individuals/members of the household were dead”**;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 9th Sangguniang Panlungsod, to grant financial assistance to the **four (4) families** affected by a fire on **December 18, 2022** located at **No. 2801 Larbaf Street, Bruger Subdivision, Barangay Putatan, Muntinlupa City** amounting to **One Hundred Twenty Thousand Pesos (Php120,000.00)**.

FURTHER, the Community Affairs and Development Office is hereby directed to release the mandated **Seven Thousand Five Hundred Pesos (Pph7,500.00)** burial assistance to the nearest family member as mandated by existing ordinance;




