WHEREAS, Article II Section 23, of the Philippine Constitution states that, "**The state shall encourage non-governmental, community-based, or sectoral organization that promote the welfare of the nation**";

WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "**Local Government units shall promote the establishment and operations of the People's and Non- Government organizations to become active partners in their pursuit of local autonomy**";

WHEREAS, Section 7 of Ordinance No. 05-040, states that, "**The organization duly accredited by the Sangguniang Panlungsod may be entitled to assistance, financial or otherwise for its economic, socially-oriented, environmental, environmental and cultural projects to be implemented within the territorial jurisdiction of Muntinlupa City**";

WHEREAS, Ordinance No. 05-040 as amended by the City Ordinance No. 06-093, states that, "the organization duly accredited by the Sangguniang Panlungsod shall enjoy privileges of an accredited organization for **three (3) years** from the time the Chief Executive signs the Resolution for accreditation. **Provided that:**

1. The organization must still submit on an annual basis a copy of its annual report to the **Securities and Exchange Commission (SEC)** or a copy of the annual report to the **Housing and Land Use Regulatory Board (HLURB)**, Or **Cooperative Development Authority (CDA)** or whatever national agency which requires submission of annual report.
