A RESOLUTION STRONGLY CONDEMNING THE BRUTAL KILLING OF POLICE LIEUTENANT REYNALDO ORCINE SAMSON, CHIEF OF POLICE OF THE MUNICIPALITY OF AMPATUAN, MAGUINDANAO, ON 31 AUGUST 2022, AND CALLING THE PHILIPPINE NATIONAL POLICE TO CONDUCT A THOROUGH INVESTIGATION SPARING NO EFFORT IN BRINGING JUSTICE

WHEREAS, on 30 August 2022, *Police Lieutenant Reynaldo Orcine Samson, Chief of Police* in the **Municipality of Ampatuan, Maguindanao** was ambushed by armed men in **Barangay Kapinpilan**, while in the performance of public duty serving a warrant of arrest against a certain **Kamir Kambal**, an accused in a criminal case of robbery with violence;

WHEREAS, based on report, **PLt. Samson** died on the spot with **Police Corporal Salipuden Talipasan Endab**, and three other policemen were wounded in the attack perpetrated by a group led by one **Guipar Abdulkarin** and/or **Bantukan Andog**;

WHEREAS, PLt. Samson was a product of the public education system of the City of Muntinlupa, having completed his elementary education in Alabang Elementary School; his secondary education in Pedro E. Diaz High School; and his tertiary education in then Muntinlupa Polytechnic College (MPC), now the Pamantasan ng Lungsod ng Muntinlupa (PLMun), where he obtained his degrees in education and criminology, and post-graduate studies obtaining Master's Degree in Educational Administration;”

WHEREAS, PLt. Samson, was the President of the MPC-PLMun Alumni Association and, as such, sat as a Member of the Board of Regents representing the alumni;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to strongly condemning the brutal killing of Police Lieutenant Reynaldo Orcine Samson, Chief of Police of the Municipality of Ampatuan, Maguindanao, on 31 August 2022, and calling the Philippine National Police (PNP) to conduct a thorough investigation sparing no effort in bringing justice.
