WHEREAS, Article II Section 23, of the Philippine Constitution states that, "The state shall encourage non-governmental, community-based, or sectoral organization that promote the welfare of the nation";

WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "Local Government units shall promote the establishment and operations of the People's and Non- Government organizations to become active partners in their pursuit of local autonomy";

WHEREAS, Section 4 of Ordinance No. 96-81, provides that, "All legitimate cooperatives shall be exempted from all taxes, fees and impositions imposed by the City Government in connection with the operations of cooperative";

WHEREAS, Section 5, of the same Ordinance, provides that, "In the event that a legitimate cooperative which deals with both members and non-members have exceeded its accumulated reserves plus undivided savings by more than Ten Million Pesos (php10,000,000.00) as provided by Section 22, Article V of Republic Act 6938 the exemption provided under this ordinance shall not apply.";

WHEREAS, Section 7 of Ordinance No. 05-040, states that, "The organization duly accredited by the Sangguniang Panlungsod may be entitled to assistance, financial or otherwise for its economic, socially-oriented, environmental, environmental and cultural projects to be implemented within the territorial jurisdiction of Muntinlupa City".

**WHEREAS**, Ordinance No. 05-040 as amended by the City Ordinance No. 06-093, states that, "the organization duly accredited by the Sangguniang Panlungsod shall enjoy privileges of an accredited organization for **three (3) years** from the time the Chief Executive signs the Resolution for accreditation. **Provided that:**

- I. The organization must still submit on an annual basis a copy of its annual report to the **Securities and Exchange Commission (SEC)** or a copy of the annual report to the **Housing and Land Use Regulatory Board (HLURB)**, Or **Cooperative Development Authority (CDA)** or whatever national agency which requires submission of annual report.
- II. The Organization must still submit the annual or biennial report as the case may be, of the results of the elections of its new set of officers or Board of Directors.
- III. The organization must still submit an annual financial report and annual accomplishment report as required by the ordinance.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to grant the accreditation to Amkor Technology Philippines Employees Cooperative with Office address located at No. Km. 22 East Service Road, South Superhighway, Barangay Cupang, Muntinlupa City.

**RESOLVED FURTHER THAT**, Section 11 of Ordinance No. 05-040, provides that, "**Any organization and its officers who are found to have used its accreditation for illegal purposes shall be prohibited from seeking accreditation and shall be blacklisted. Any organization violating the terms and conditions of its accreditation shall not be renewed and shall not enjoy privileges provided under this ordinance**".

**FINALLY RESOLVED**, that copy of this resolution, shall give to aforementioned organization for its records and legal purposes.

**ADOPTED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 12<sup>th</sup> day of September 2022, on its 11<sup>th</sup> Regular Session.
