WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), on General Welfare, mandates that, "Every Local Government Unit shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 17(a) of the LGC, on Basic Services and Facilities, states that, "(a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein;"

WHEREAS, Section 458(a)(1) of the LGC, on the Powers, Duties, Functions, and Compensation of the Sangguniang Panlungsod, provides that, "(a) The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

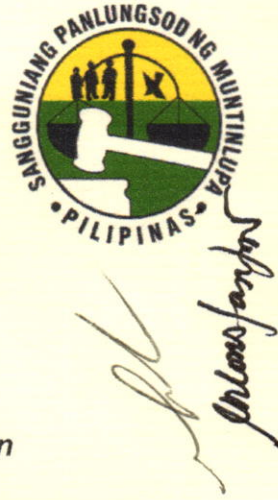

(1) Approve ordinances and pass resolutions necessary for an efficient and effective city government;"

WHEREAS, the Metro Manila Skyway System (Skyway) Stage 2 Project of the Department of Public Works and Highway (DPWH) is the continuation of Stage 1 elevated expressway with a toll road of about 6.88 km from Bicutan, Parañaque City to Alabang, Muntinlupa City over the South Luzon Expressway with the aim to further mitigate the traffic congestion in the major thoroughfares in Metro Manila;

WHEREAS, the implementation of the Skyway Stage 2 Project caused the temporary closure of the Northbound Alabang Exit located in the south end of the East Service Road in 2020, which greatly affected the traffic situation in the said service road stretching to and from Barangays Alabang and Sucat;

WHEREAS, following the completion and full operations of the Skyway Stage 2 Project in the early 2022, the City Council deems it necessary to re-open the Northbound Alabang Exit to effectively decongest the pool of vehicles along the East Service Road;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to request the San Miguel Corporation South Luzon Expressway, Inc. (SMC SLEX, Inc.) to re-open the Northbound Alabang Toll Exit located in the East Service Road, Barangay Alabang, Muntinlupa City.

RESOLVED FURTHER, that copies of this Resolution be furnished all concerned Agencies/Offices for their information.




