WHEREAS, Article XIII Sec 11 of the 1987 Constitution provides, **"The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers."**;

WHEREAS, one of the major challenges in the Philippine health sector is providing access to appropriate health facilities for the poor and the marginalized sector of the society, hence, the national government, recognizing this problem, implemented the Health Facilities Enhancement Program (HFEP) for the upgrading of health facilities as well as providing training to health professionals to improve the access of people to quality health care;

WHEREAS, the HFEP project envisions the revitalization of primary health care facilities and the rationalization of the various levels of hospitals to decongest end-referral hospitals to provide Basic Emergency Obstetric and Newborn Care (BEmONC) and Comprehensive Emergency and Newborn Care (CEmONC) services to the population, and to strengthen the health facility referral system or network;
