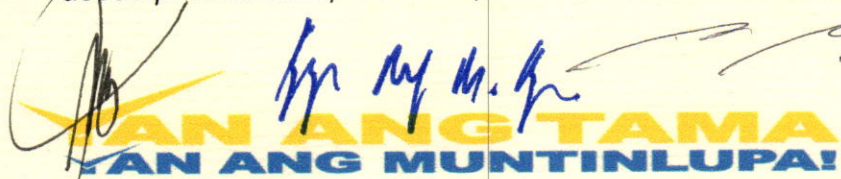

WHEREAS, Article II Section 23, of the Philippine Constitution states that, **"The state shall encourage non-governmental, community-based, or sectoral organization that promote the welfare of the nation"**;

WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"Local Government units shall promote the establishment and operations of the People's and Non- Government organizations to become active partners in their pursuit of local autonomy"**;

WHEREAS, Ordinance No. 05-040 as amended by the City Ordinance No. 06-093, states that, "the organization duly accredited by the Sangguniang Panlungsod shall enjoy privileges of an accredited organization for *three (3) years* from the time of the Chief Executive signs the Resolution for accreditation. Provided that:

- I. *The organization must still submit on an annual basis a copy of its annual report to the Securities and exchange commission (SEC) or a copy of the annual report to the Housing and Land Use Regulatory Board (HLURB), Or Cooperative Development Authority (CDA) or whatever national agency which requires submission of annual report.*
- II. *The Organization must still submit the annual or biennial report as the case may be, of the results of the elections of its new set of officers or Board of Directors.*
- III. *The organization must still submit an annual financial report and annual accomplishment report as required by the ordinance.*
