BIAZON TO REPRESENT MUNTINLUPA IN A MEMORANDUM OF AGREEMENT (MOA) WITH OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), ON THE ESTABLISHMENT OF HELP DESK WHICH WILL ACT AS CONDUIT IN THE DELIVERY OF SERVICES, TRAINING, WELFARE, HEALTH CARE AND REINTEGRATION OF OVERSEAS FILIPINO WORKERS (OFWs) AND THEIR RESPECTIVE FAMILIES IN THE CITY OF MUNTINLUPA

WHEREAS, the 1987 Constitution Article XIII Section 3 provides, ***"The State shall afford full protection to labor, local and overseas, organized and unorganized, and promote full employment and equality of employment opportunities for all."***;

WHEREAS, Republic Act No. 8042 otherwise known as the Migrant Workers and Overseas Filipinos Act of 1995 and further amended by Republic Act 10022, declared in its policy: ***"In recognizing the significant contribution of Filipino migrant workers to the national economy through their foreign exchange remittances, the State does not promote overseas employment as a means to sustain economic growth and achieve national development. The existence of the overseas employment program rests solely on the assurance that the dignity and fundamental human rights and freedoms of the Filipino citizens shall not, at any time, be compromised or violated;"***

WHEREAS, RA 10022 further improved the standard of protection and promotion of the welfare of migrant workers, their families and overseas Filipinos in distress by involving local government units (LGUs), to take proactive stance by being primarily responsible for the dissemination of information to their constituents on all aspects of overseas employment;

WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that ***“The City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;”***

WHEREAS, Section 16 of the LGC provides that, ***“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;”***

WHEREAS, on 21 October 2019, the Sanggunian passed Resolution No. 19-102 or a ***Resolution authorizing the City mayor to enter into a Memorandum Of Agreement (MOA) with the following National Government Agencies: Philippine Overseas Employment Administration (POEA), Overseas Workers Welfare Administration (OWWA), Department Of Labor And Employment (DOLE), Technical Education And Skills Development Authority, National Capital Region (TESDA-NCR) For The Establishment Of A Help Desk For the Protection of Labor, Anti-Illegal Recruitment, And Anti-Human Trafficking Campaigns;***

WHEREAS, the City of Muntinlupa pursuant to its mission to provide quality social services that include among others livelihood and employment and social assistance, cooperated with the Overseas Workers Welfare Administration (OWWA), an attached agency of the Department of Labor and Employment (DOLE), to foster protection and promotion of the welfare of Overseas Filipino Workers (OFWs) and their dependents through the establishment of a similar OFW Help Desk;

WHEREAS, the OFW Help Desk, located within the city hall premises and manned by assigned family welfare officer shall serve as conduit in the swift delivery of its programs on education and training, welfare, health care, and reintegration of OFWs and their families;

WHEREAS, the City Legal Office finds no legal impediments in the provisions setforth in the MOA and further recommend the improvement of the same to conform with the existing laws and regulations;

***NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED,*** by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the ***City Mayor Hon. Rozzano Rufino B. Biazon*** to represent Muntinlupa in a Memorandum of Agreement (MOA) with ***Overseas Workers Welfare Administration (OWWA)***, on the establishment of help desk which will act as conduit in the delivery of services, training, welfare, health care and reintegration of ***Overseas Filipino Workers (OFWs)*** and their respective families in the City of Muntinlupa.

**ADOPTED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 3<sup>rd</sup> day of October 2022, on its 14<sup>th</sup> Regular Session.






