A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH D.L. WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project construction of **tapping of electrical supply (From Lakeview Senior High School To Lakeview Integrate School) located at Barangay Putatan, Muntinlupa City** in the newspaper of general circulation likewise posted at the Government Electronic Procurement System (GEPS) City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **September 1, 2022**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **D.L. Cervantes Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Three Million Two Hundred Thirty-Five Thousand Four Hundred Twenty-Seven Pesos and 68/100 (Php3,235,427.68)**;

WHEREAS, the project was awarded to **D.L. Cervantes Construction Corporation** who being the lowest bidder for the project construction of **tapping of electrical supply (From Lakeview Senior High School To Lakeview Integrate School) located at Barangay Putatan, Muntinlupa City**;
