CLEMENTE Construction Corporation's bid has been responsive to Approved Budget for the Contract (ABC) amounting to Two Million Five Hundred Thirty-Six Thousand Five Hundred Ninety-Eight Pesos and 14/100 (Php2,536,598.14);

WHEREAS, the project was awarded to I.F. Clemente Construction Corporation who being the lone bidder for the project construction of upgrading of Electrical System located at Muntinlupa Elementary School Poblacion, Muntinlupa City;
