WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **I.F. CLEMENTE Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to Two Million Five Hundred Thirty-Six Thousand Five Hundred Ninety-Eight Pesos and 14/100 (**Php2,536,598.14**);

WHEREAS, the project was awarded to **I.F. Clemente Construction Corporation** who being the lone bidder for the project construction of **upgrading of Electrical System located at Muntinlupa Elementary School Poblacion, Muntinlupa City**;




