WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

WHEREAS, Section 106 of RA 7160, **“Mandates its local government to prepare a comprehensive multi-sectoral development plan to be initiated by Development Council and approved by its local Sanggunian. For this purpose, the development council at the city level shall assist the corresponding Sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction”**;

WHEREAS, on October 13, 2015 the Local Development Council (LDC) approved the **City’s Comprehensive Land Use Plan (CLUP) 2016-2026** by virtue of Resolution No. 2, s. 2015;

WHEREAS, the Local Development Council (LDC) adopted the **City’s Comprehensive Development Plan (CDP) 2017-2023** as Sectoral Plan of the approved CLUP 2016-2026 on August 18, 2017 by virtue of Resolution No. 1, s. 2017;

WHEREAS, the City Development Council (CDC) approved **Resolution No. 1 s. 2022** approving the **Annual Investment Program (AIP)** of the City of Muntinlupa for Fiscal Year (FY) 2023;




