A RESOLUTION URGING THE NATIONAL YOUTH COUNCIL (NYC), DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), COMMISSION ON ELECTION (COMELEC) TO FACILITATE THE RELEASE OF THE IMPLEMENTING RULES AND REGULATIONS FOR REPUBLIC ACT 11786 OTHERWISE KNOWN AS "AN ACT STRENGTHENING THE SANGGUNIANG KABATAAN, INSTITUTIONALIZING ADDITIONAL REFORMS TO REVITALIZE YOUTH PARTICIPATION IN LOCAL GOVERNANCE AND BY PROVIDING HONORARIUM, OTHER BENEFITS, AND PRIVILEGES, AMENDING FOR THE PURPOSE CERTAIN SECTIONS OF REPUBLIC ACT NO. 10742, 1748 OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF


WHEREAS, Section 426 of the Local Government Code of 1991, provides for the powers and functions of the Sangguniang Kabataan which includes: "Exercise such other powers and perform such other duties and functions as the Sangguniang Barangay may determine or delegate or as may be prescribed by law or ordinance";


WHEREAS, Republic Act 11786 otherwise known as An Act Strengthening the Sangguniang Kabataan (SK), Institutionalizing Additional Reforms to Revitalize Youth Participation in local governance and by providing honorarium, other benefits, and privileges, amending for the purpose certain sections of Republic Act No. 10742, otherwise known as the "Sangguniang Kabataan Reform Act of 2015" was approved May 06, 2022;

WHEREAS, Section 6, supra, provides that, ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan. SK fund shall likewise be allocated in the annual budget in accordance with the adopted

Annual Barangay Investment Program;
