WHEREAS, Republic Act 9155 otherwise known as the Governance of Basic Education Act of 2001, provides that, **one of the Act's purposes and objective is to establish schools as facilities where schoolchildren are able to learn a range of core competencies prescribed for elementary and high school education program;**

WHEREAS, DEPED Order No. 40, series of 2014 **provides for the Revised Guidelines on the Establishment, Merging, Conversion, and Naming/Renaming of Public Schools, and Separation of Public Schools Annexes in Basic Education;**

WHEREAS, under the same Order, requests for creation of new schools whether initiated by the Central, Regional or Division Office, or any stake holder, must be in accordance with DepED criteria and standards. The said requests, under DEPED Order No. 40, shall undergo evaluation by the concerned committees (Division Review and Evaluation Committee, Regional Inspectorate Team) until approval of the Regional Director approved the same;

**WHEREAS**, based on the data given by the Division Office on the public secondary schools for the school year 2022-2023, enrollees for public secondary schools in the City (Muntinlupa National High School, Muntinlupa National High School-Annex, Tunasan National High School, Muntinlupa Science High School, Pedro E. Diaz High School, Muntinlupa Business High School and Muntinlupa Business High School-Sucac Annex), total to 31,926 as of October 17, 2022;

**WHEREAS**, Muntinlupa City has a population growth rate of 1.58% based on the 2020 census of Philippine Statistics Authority (PSA) and composed mainly of citizens who are qualified for secondary education, hence, a need to establish more schools to decongest existing schools thereby upgrade the quality of learning and instruction in our city;

**WHEREAS**, the establishment of new schools is in consonant with the 7K agenda under "Karunungan" of the **Honorable Mayor Rozzano Rufino B. Biazon**. Under said agenda, the importance of education of as a means in achieving personal growth thus contributing to the country's development is being underscored by the administration;

**WHEREAS**, the creation of an additional national high school to be known as **Sucac National High School** at Sucac, Muntinlupa City is the fruition of the commitment of the City Government to its constituency on its vision of "educated people embodied in the City's Vision";

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to request the **Hon. Atty. Jaime R. Fresnedi**, representative of the Lone Congressional District of Muntinlupa, to sponsor a bill in Congress creating a new **Sucac National High School** in Muntinlupa City.
